2.	Status of TEQIP III and Action Plan for April-May-June 2019:		
	Member Secretary presented the status of TEQIP-III project. The board members have approved the Action Plan under TEQIP-III project for April-May-June 2019. Total value of action plan is Rs. 10790000/		
3.	Status of NBA preparedness:		
	At first Member Secretary presented the detailed status of NBA application SAR preparedness status. Only one batch has passed out under SKM University, Dumka. Due to the uncertainty the publication of 2^{nd} , 4^{th} and 6^{th} semester examination result, which was held in the month of October 2018 and in conducting of University examinations, odd semester examinations (3^{rd} , 5^{th} and 7^{th}) for the academic year 2018-19 had not been conducted yet. Therefore, it was unknown when the other batch would be passed out. Thus, it was decided that the final date of NBA applications will be decided later based on the outcomes of the above.		
	Along with the SAR preparation, the Chairperson has emphasised to improve the academic atmosphere. In order to achieve this he suggested following back to basic philosophy by providing College Diary to all students for maintaining all academic records. Also, he suggested changing the orientation of a class so that a teacher can reach every student. Moreover, he proposed to encourage students for conducting some innovative projects from all departments. He added that to start such activity, the students will be encouraged to identifyrelevant problems and motivate other students to work on those problems.		
	Board accepted the suggestion of the Chairperson.		
4.	Recruitment of Professor and Associate Professor:		
	In order to maintain required faculty cadre proportion, recruitment of one Professor and two Associate Professors. Member Secretary mentioned that we have started the recruitment process.
